

FY24/25 Highlights

Annual Report Highlights

Improvements at Starr's Cave Nature Center

With grants from the Murray Foundation and other donations, we completed ADA-accessible walkways at Starr's Cave Nature Center. The new sidewalks now connect a paved parking area to the nature center, the shelter house, and the ADA-accessible trail.

With a grant from Delta Dental, we replaced our 30+ year old nonfunctioning outdoor water fountain with a new hydration station that includes a drinking fountain, bottle filler, and even a dog waterer.

Inside the nature center we updated some displays and added changing stations in the bathrooms.

Due to a water line leak somewhere under Irish Ridge Road that resulted in a couple months without water at the Nature Center, we ended up

contracting with Rathbun Rural Water Association to run new water service to the park.

New software, fee structure

This year we implemented new event and membership management software called RecDesk. Now, registration for almost all of our events are run through the system as well as our shooting range memberships. The system also allows for digital check in at events and at the shooting range.

We also increased fees this year. Full hookup campsites went from \$25 to \$30, electric-only sites went from \$20 to \$25, and we went to a single household membership rate for the shooting range at \$45. Lifetime shooting range memberships went from \$500 to \$750.

Foundation hosts inaugural River Days event

The Partners for Conservation Foundation, a local nonprofit that supports much of the work we do here at the conservation department, hosted the inaugural Burlington River Days event in June. The event featured live music, a carnival, a boat parade and boat show, and "River Days Olympics" – a series of fun challenges hosted by local conservation and wildlife organizations. There was even a giant giveaway, the grand prize of which was a brand new boat. The event raised over \$20,000 for the foundation and plans are already underway for next year's event.



Staff Update

Part-time technicians Bryce Wade left this year and was replaced by Jacklyn Wolken who previously served as our Naturalist. We hired Shania Hansen to fill the Naturalist role. Shania previously worked in Henry County as an assistant naturalist.

Technician Derek Hester left in May. We promoted Brian Havener into that position. Brian had been one of the parttime technicians prior to that. Due to budget constraints, we did not backfill that part-time technician position.

Grant Swanson returned for his third summer internship with our field team. Kendall Colter also joined the team for

her first summer internship with us. At the nature center, Trevor Skalinski joined the Environmental Education team for his first summer internship, though he has volunteered with us many times in the past.







Where Are People Camping? Based on total nights, FY24/25



LAND STEWARDSHIP

Our focus this year was on maintenance. We worked hard at staying on top of invasive species, doing the maintenance mowing on areas that we had cleared last year, and applying fire when and where we can. Our fall burn season was short, resulting in fewer timber burns than we had hoped for. We also added some new food plots this year.

ENVIRONMENTAL/CONSERVATION EDUCATION PROGRAM Activities of the EE Program Staff JULY 2024 – JUNE 2025

Programs, Events, and Services

For the Fiscal Year 2024-2025, the Environmental Education Department at Starr's Cave Nature Center recorded a total of 16,449 visitors accessing our facilities and grounds. This figure is notable, especially considering it includes a month where the door counter malfunctioned in September, showing 0, meaning our actual casual visitation for the full year is likely even higher than reported. This overall visitation figure represents a change from the previous year's peak of 19,393.

The shifts in our program and participant numbers were significantly influenced by the active recruitment for a new naturalist position, which created a staffing gap impacting our core capacity for conservation education – a foundational element of our mission to develop an environmentally responsible community. Specifically, we were unable to offer spring field trip programming or in-class programming during this period, which contributed significantly to the observed decreases in school and youth group participation.

Despite these challenges, we remained steadfast in our commitment to the quality and variety of our environmental education programming. Through the dedicated efforts of our team, we continued to offer impactful annual educational programs such as Eagle Watch, Summer Camps, Monarch Watch, Fishing activities, Firearm Safety, and Hunters Education courses, all meticulously



designed to foster environmental stewardship and provide outstanding outdoor recreation opportunities that complement learning. Beyond these, we also successfully hosted a diverse range of running and trail usage events that encouraged active participation, including the Memorial Day Veterans 5k, The Gobble Hobble, Ugly Sweater 5k, Westland Mall Crawl, Woodland Warrior Challenge Run, Donate Life 5k, and Mayday Half Marathon, further broadening our community engagement.

Casual visitation reached 11,911 for FY 24-25, indicating robust public engagement with the natural resources and facilities we manage through land stewardship, providing a vital backdrop for our educational efforts. While many traditional educational groups, such as those for preschool through fifth graders and youth groups, saw notable decreases in participation due to the specific programming gaps mentioned, public programs were a positive outlier, experiencing a substantial increase of 495 participants to a total of 2,378, even with fewer program offerings.

Demonstrating adaptability and our commitment to our vision for department administration, we also successfully launched new initiatives like Hook & Hunt and CORES (Community Outdoor Recreation Education Specialist) to diversify our outreach and educational methods. Regarding monthly trends, participation generally peaked in the fall (with September's casual visitation data being absent due to the malfunction),

with October displaying high engagement, while program numbers were higher in summer months like July and June. Winter months (December to February) typically saw a noticeable slowdown. This data highlights a transitional year, where the impact of a key personnel vacancy was evident in our environmental education outreach, but also underscored our ability to maintain program quality, innovate, and uphold our department's mission.

Furthermore, enhancing our commitment to providing quality and accessible outdoor education, we finished the concrete ADA accessibility project, significantly improving access for all visitors to our educational facilities and trails, and, through a generous Delta Dental Grant, successfully installed an outdoor bottle filling station, promoting sustainability and convenience for our program participants.

This ongoing success is made possible through the generous support of our community partners, including Kiwanis of Burlington, the Aldo Leopold Chapter of Pheasants Forever, The Murray Foundation, and the Community Foundation, to name a few, who are vital to sustaining our environmental education initiatives.
