

September 17, 2013

The Des Moines County Board of Supervisors met in regular session at the Court House in Burlington at 9 AM on Tuesday, September 17th, 2013, with Tom Broeker, Bob Beck and Jim Cary present.

Unless otherwise noted, all motions carried.

Meet with Department Heads: Chris Lee, Director of County Conservation, reported that there is a vacancy on the Conservation Board. Interested persons should apply by letter to his department. CPC Ken Hyndman reported that the MHDS committee was meeting on Thursday to finalize rules for regionalization. The regional group will be meeting on Friday to continue working on their 28E agreement.

The following correspondence was received: Beck reported a phone call from a rural resident who was concerned about people using recycle bins at the Beavertdale Trading Post for garbage.

Accounts Payable Claims in the amount of \$494,532.51 were approved upon motion by Cary and second by Beck.

Bob Bartles, Director of Hope Haven, was present to request the abatement of 2012 taxes for properties on North 7th St. Hope Haven acquired the property in August 2012 and the deadline to apply for tax exempt status for that tax period was Feb. 2012. The application will take effect for the taxes assessed for the 2013 tax year. Assistant County Attorney Amy Beavers was asked to check the Code to see if the Board has authority to cancel these taxes. Motion to table this item until next week was made by Cary and seconded by Beck.

County Engineer Brian Carter presented a Resolution to install Stop Signs and explained that the signs were replacing Yield Signs that have been damaged. Broeker read the Resolution. Motion to approve was made by Cary and seconded by Beck.

RESOLUTION

WHEREAS Chapter 321, Section 255 of the 2013 Code of Iowa states that authorities in their respective jurisdiction shall erect and maintain such traffic control devices upon highways under their jurisdiction as they deem necessary to carry out the provisions of the chapter, and

WHEREAS certain intersections in the County meet stop sign warrants per the Manual of Uniform Traffic Control Devices (MUTCD) Section 2B05, and

NOW, THEREFORE, BE IT RESOLVED that the Board of Supervisors of Des Moines County, Iowa, on the 17th day of September 2013 deem it necessary to remove the yield sign and erect and maintain a stop sign at the following described intersections:

250th Street & 180th Avenue-North and Southbound traffic to stop

260th Street & 78th Avenue-Southbound traffic to stop

170th Street & 85th Avenue-Eastbound traffic to stop

Hunt Road & Rock Spring Road-Southbound traffic to stop

135th Street and 190th Avenue-Northbound traffic to stop

Broeker read a Letter of Understanding which explained that the County and CWA have reached an agreement to retain the current level of custodial employees. One vacancy will be filled by contract with an outside custodial service. Motion to approve was made by Beck and seconded by Cary.

James Burton Graham, Operations Supervisor for County Conservation, received a salary increase due to completing his 6 month probation. Motion to approve was made by Cary and seconded by Beck.

Beck moved to cancel Treasurer's checks that have been outstanding for more than one year. Seconded by Cary. The checks totaled \$34.76.

A decision must be made due to the condition of their present location.

Committee reports: Cary attended a RUSS meeting. He reported that the financial condition of this group is critical. There is only enough money to fund operations for two months. RUSS is suing Mt. Union for \$295,000 for payment of their project. If Mt. Union defaults, the counties in the 28E agreement must pay for the project. Cary also reported that not all member counties are paying their dues. Broeker attended a Grow Greater meeting this morning and explained the County's budgeting process. At the COB/CO meeting last week, a letter from the City of Burlington's attorney was disclosed in which he advised that the insurance group was not required to conduct an annual audit.

Meeting was adjourned at 9:56 AM.
