

October 21, 2014

The Des Moines County Board of Supervisors met in regular session at the Court House in Burlington at 9 AM on Tuesday, October 21<sup>st</sup>, 2014, with Bob Beck, Jim Cary and Tom Broeker present.

Unless otherwise noted, all motions carried.

Meet with Department Heads: the Auditor reported that a third candidate has filed papers for Burlington City Council, which necessitates a Primary Election on December 2<sup>nd</sup>. Copeland also reported that her office has sent 5,533 absentee ballots for the November 4<sup>th</sup> General Election, with 2,940 returned. County Engineer Brian Carter reported that Mediapolis Road was opened last night. Local drivers should use caution while driving the new road because the contractor is still working in the ditches. On 140<sup>th</sup> St. the contractor is doing some final dirt work that should be seeded this week. Three culverts need to be installed but grading and rocking are done. Secondary Roads crews are doing some asphalt work on DMC 99. Chief Deputy Jeff White reported that he attended an E911 Board meeting. An infrastructure plan was approved for radio towers at Wever and Meeker's Landing. Conservation Director Chris Lee reported that a forestry project, which was funded by a grant, was finished at Big Hollow. By the end of next week, all campgrounds will be closed for the season. Safety Director Angie Vaughan reported that employees were given wellness training in October. In November, she will be holding trenching and excavation training for the Fire Department. Employees will receive CPR training if they choose to participate. Community Services Director Ken Hyndman reported that he has received notification from the State that he must remit \$61,850 in Medicaid offset funds by the end of the year. Public Health Director Barb Baker reported that the Des Moines County Health Care Coalition is ordering personal protective equipment in case of Ebola cases happening locally. Homeland Security is now screening all travelers coming from West Africa. If they come to Iowa, the State Dept. of Health will be notified. In turn, the local Health Departments will be notified and will monitor changes in that person's health.

Accounts Payable Claims in the amount of \$489,098.17 were approved upon motion by Broeker and second by Cary.

Dan Eberhardt was reappointed to another four year term as Franklin Township Clerk. Motion to approve was made by Cary and seconded by Broeker.

Broeker moved to approve a one year extension on the lease for the County Attorney's office at the U S Bank building. Seconded by Cary. The agreement remains the same.

Resolutions to appoint McGladrey LLP to conduct the annual audit for Catfish Bend Casinos II, LLC and CPS Associates PC to conduct the annual audit for Southeast Iowa Regional Riverboat Commission were approved upon motion by Broeker and second by Cary.

Broeker moved to approve a Class C Liquor License for Yarmouth Filling Station Bar & Grill. Cary seconded.

The following personnel actions were approved: at County Conservation, Dilan Beaird and Patrick Moore, both seasonal conservation technicians, ended their temporary employment on October 24<sup>th</sup>. Motion to approve was made by Cary and seconded by Broeker.

The Sheriff's report of fees collected for September, 2014, was received and filed.

Minutes for a work session held on October 13<sup>th</sup>, 2014, were approved upon motion by Broeker and second by Cary.

Cary moved to approve minutes for the regular Board meeting held on October 14, 2014. Seconded by Beck. Roll-Call Vote: Cary, Aye Beck, Aye Broeker, Abstain

During committee reports, Cary had attended an Early Childhood meeting. Director Sally O'Reilly is retiring Nov. 1<sup>st</sup> and they are seeking an interim director. They also sent a letter to the State asking to join with Washington and Henry counties. Broeker attended meetings of Grow Greater Burlington and MHDS. Gallagher has signed as broker for COBCO. Beck attended a union grievance meeting.

Meeting was adjourned at 9:57 AM.
