

April 21, 2015

The Des Moines County Board of Supervisors met in regular session at the Court House in Burlington at 9 AM on Tuesday, April 21st, 2015, with Jim Cary, Tom Broeker and Bob Beck present.

Unless otherwise noted, all motions passed unanimously.

Meet with Department Heads: Doug Ervine, Jail Administrator, reported 54 inmates this morning. His staff was working transport and security for a jury trial going on. Director of Community Services Ken Hyndman reported that the crisis stabilization center in Jefferson County opened April 20th. Hospitals will still diagnose and treat patients for adjustment of medications and chemical detox, and crisis centers can be used for behavioral problems. With the scheduled closure of the MHI at Mt. Pleasant, centers like this will be important for voluntary treatment. County Attorney Amy Beavers toured commercial spaces Sunday afternoon but there was nothing suitable for her office. Conservation Director Chris Lee reported that the berms at the shooting range are done. Starr's Cave open house is next Monday. Campers are using every campground and fish are biting. Nature Center Manager Kent Rector will appear on the Paula Sands Show on WQAD on Wednesday. County Engineer Brian Carter stated that crews are still working on soft roads.

Under correspondence, Broeker announced that the county will be receiving a refund on fiscal year 2014 Work Comp premiums in the amount of \$68,660. This is due to a good safety record.

Broeker moved to open a public hearing for the third and final reading of an amendment to Ordinance 6F. Seconded by Beck. Cary asked if the audience wanted the Ordinance read. No one responded. Cary stated that the amendment will provide for the appropriate fire chief to sign off on the fireworks permit. Also, no one under 18 will be permitted to set off fireworks. There was no public comment. Motion to close the public hearing was made by Broeker and seconded by Beck. Broeker moved to approve the amendment to Ordinance 6F. Beck seconded. Roll-Call Vote: Broeker, Aye Beck, Aye Cary, Aye.

Accounts Payable Claims in the amount of \$363,121.98 were approved upon motion by Beck and seconded by Broeker.

A request to suspend real estate taxes on a property located in Danville was forwarded from DHS by the County Treasurer. Pointing out that the taxes will be paid when the property changes hands, Broeker moved to approve the suspension. Beck seconded.

Janelle Nalley-Londquist, County Treasurer, also requested cancellation of mobile home taxes on a home that is junked and the owner can't be located. Motion to approve was made by Beck and seconded by Broeker.

An application for a refund of the liquor permit for Yarmouth Café was received. The owner is entitled to a refund of one-half of the County's share of the fees, which is \$195. Broeker moved to approve. Seconded by Beck.

Dilan Beaird has been hired as spring intern at the Conservation Department. He will work from April 6th through May 29th at the rate of \$9.50 per hour. Beck moved to approve. Seconded by Broeker.

The Sheriff's Report of Fees collected for March 2015 was received and filed.

Broeker moved to approve minutes for the Board meeting held on April 14th, 2015. Seconded by Cary. Roll-Call Vote: Broeker, Aye Cary, Aye Beck, Abstain

During committee reports, Beck had testified to the DOT on behalf of Highway 61 Coalition. He also attended a SEIPRC meeting. Broeker attended COBCO, MHDS Commission and Grow Greater Burlington meetings. He worked on community cleanup on Saturday.

Meeting was adjourned at 9:36 AM.

A work session to discuss the recommendations of the ICAP Loss Control Agent was held following the meeting. One recommendation was that employees who drive county vehicles must have their current driver's license verified annually. Chief Deputy Jeff White stated that just seeing the license isn't enough proof. The validity of the license needs to be checked by the DesCom office. Beck thought that the labor attorney should be involved in writing the policy and asked the Auditor to contact the insurance agent for written direction. The other suggestion was that department heads do written evaluations every year.

The next work session was regarding the smoking policy. The County's policy is stricter than State law. The Auditor asked that the policy be rescinded and a new one written. The County Attorney will have this ready for a future meeting.

The last work session concerned the Dust Control Program. Carter distributed maps showing Tier One and Tier Two roads for the program and reported that he was considering using Magnesium Chloride in the future.

Chris Lee, Conservation Director, took the Supervisors on a field tour of conservation projects.
