Land Use Administrator Zach James reported they have a couple subdivisions in the works. Conservation Director Chris Lee stated the projects at Big Hollow are in process. The rain we have been receiving has held back some of the progress. He is looking forward to Memorial Day weekend at Big Hollow, as it is their busiest week of the year. Emergency Management Director Shannon Prado stated we have storms moving in today. Please be alert and have a couple of different ways to receive alerts in case of a power outage. MHASEI CDS Director Ken Hyndman was present with a Mental Health update. County Treasurer Janelle Nalley-Londquist stated she attended Iowa State County Treasurers meetings last week. There has been new legislation that has passed to be effective January 1 and it will require a lot of programming statewide.
