The Des Moines County Board of Supervisors met in regular session at the Court House in Burlington at 9:00 AM on Tuesday, January 21st, 2025, with Chair Jim Cary. Vice Chair Shane McCampbell and Member Tom Broeker present via Webex. This meeting was also held electronically via Webex and YouTube live streaming. Public input was available through board email or call in.

Unless otherwise noted, all motions passed unanimously. The Pledge of Allegiance was conducted.

Meeting with Department Heads: County Auditor Sara Doty stated she is currently conducting interviews for the open position in her office. Her office is busy preparing budget and for the upcoming Special Elections. IT Director Colin Gerst reported his office is busy. Sheriff Kevin Glendening stated his office is currently hiring for a Clerk II. Jail population is at 92. Local Health Director Christa Poggemiller reported there was a Board of Health meeting last week. They had a quorum, so they did not vote on any business. Safety Director Angela Vaughan reported her office is busy. Emergency Management Director Shannon Prado reported we have been updated from a cold weather advisory to an extremely cold warning. Warming centers are open as follows: Transitions DMC, open 24 hours; Mediapolis City Hall, open during business hours; and Burlington Public Library, open during business hours. County Assessor Matt Warner reported he is working on assessments. The Conference Board will be meeting within the next few weeks. Assistant Land Use Administrator Jarred Lassiter is present for an agenda item. County Engineer Brian Carter reported there is an asphalt bid opening tomorrow morning at 10:00 a.m. His office is currently working on various grant opportunities.

No correspondence was received.

Approval of Accounts Payable Claims in the amount of \$1,086,890.85 were presented. McCampbell made a motion to approve and was seconded by Broeker.

Approval of Payroll Reimbursement Claims in the amount of \$335.50 were presented. Broeker made a motion to approve and was seconded by McCampbell.

Approval of Law Enforcement Agreement between Middletown and Des Moines County for FY25/26 was presented. McCampbell made a motion to approve and was seconded by Broeker.

Approval of Resolution #2025-005 Subdivision Ordinance Waiver – Auditor's Parcel "E" (Wes Ames) was presented. Assistant Land Use Administrator Jarred Lassiter introduced the Waiver and recommended approval. Broeker made a motion to approve and was seconded by McCampbell.

DES MOINES COUNTY BOARD OF SUPERVISORS RESOLUTION #2025-005

WHEREAS Section 354.8 of the Code of Iowa states that a governing body shall certify by resolution the approval of a subdivision plat, and,

WHEREAS Article I, Section C(3) of the Des Moines County Subdivision Ordinance states that, "when an existing lot is to be enlarged through a plat of survey...this shall not be considered a subdivision unless the area to be added constitutes greater than fifty percent of the total enlarged lot", and

WHEREAS, the Des Moines County Auditor and Land Use Administrator determined that a certain plat of survey requested by Wes Ames, and assigned the name Auditor's Parcel "E" was exempt from the requirement for a subdivision, since its 13.68 acres constituted less than 50 percent of the cumulative acreage of it and the adjoining lot it was to be combined with (Parcel "B", at 82.34 acres), and

WHEREAS, the Plat of Survey for Parcel "E" was recorded as instrument #2024-003598 on September 11, 2024, with a Surveyor's Note stating that, "Auditor's Parcel 'E' hereon, shall be combined with adjacent Parcel 'B' westerly for purposes of taxation, assessment, zoning, etc. and shall not be a standalone parcel", and

WHEREAS, contrary to the conditions through which the exemption was allowed, a Warranty Deed was recorded for Parcel "E" as instrument #2024-005011 on December 12, 2024, with ownership transferred to Robert J. and Dawn M. Rohrer, owners of 3 adjoining parcels of land to the east of Parcel "E", totaling 4.95 acres, and

WHEREAS, the transfer of Parcel "E" to the Rohrers would not have qualified for the exemption specified in Article I, Section C(3) of the Subdivision Ordinance, as its 13.68 acres constituted greater than 50 percent of the cumulative acreage of it and the adjoining lot it was to be combined with, and

WHEREAS, the Board has determined that it is appropriate to exempt the Plat of Survey recorded on September 11, 2024, from the requirement of a Subdivision, based on the following factors:

The Plat of Survey was initially approved based on the best information available to County staff at the time,

and

Parcel "E" has a dedicated access easement from US Highway 61 in the event that it is ever sold separately from the Rohrers' existing property, recorded as instrument #2024-005021 on December 12, 2024,

NOW THEREFORE, BE IT RESOLVED: That Article I, Section C(3) of the Des Moines County Subdivision Ordinance shall be waived for Auditor's Parcel "E", recorded as instrument #2024-003598.
