All bidder registrations and bidding MUST be done online at www.iowataxauction.com. Interested bidders will need to complete and submit the required bidder information by 11:59 p.m. on Thursday, June 16th, 2022, in order to bid at the online tax sale. Owner's name may not include all owners of the property, as there may be additional names on the deed or a contract to purchase may exist. Taxes due may be paid online at www.iowatreasurers.org until 11:59 p.m. on Thursday, June 16th, 2022, or in the office until 4:30 p.m. on Friday, June 17th, 2022. After the sale, for parcels that are sold, if the parcel is not redeemed within the period provided in Iowa Code Chapter 447 - Tax Redemption, the right to redeem expires and a deed may be issued.
